

2019 CTA Revision Programme – Terms and Conditions

This revision programme is designed for students registered for CTA, which consists of Auditing, Financial Accounting, Management Accounting and Taxation modules.

Terms and Conditions:

Payments:

1. A registration must be accompanied by a fully completed application form and proof of payment for the course.
2. Where payment is selected on terms, the balance of fees must be collected via debit order and the completed debit order form must be submitted at registration with proof of payment for the first instalment. Where a debit order is dishonoured, a student will be suspended from the online google classroom and face to face registered students will also be suspended from accessing the Edge campus.

Where students are registered at their university on a piecemeal basis, proof of their university registration must be submitted to info@ebs.co.za with their Edge registration form for this programme. These students must register for all their university modules offered on the Edge revision programme. A quotation for the fee payable in this regard may be requested from info@ebs.co.za.

Cancellation:

1. No cancellations are accepted, including a student who does not arrive for any one day of the course.
2. Under no circumstances whatsoever will fees be refunded.

Online google revision programme classroom:

1. Students who purchase the revision programme will have access to the online google classroom for the full revision programme, which includes prerecorded sessions (updated for 2019 course content) of:
 - approximately 30 case studies with feedback sessions,
 - 2 simulated exams per modules with feedback sessions and
 - exam technique.
2. Access to the google revision programme classroom is only for the duration of the course which is from 31 July 2019 to the final UNISA CTA exam date for the calendar year.
