***Please note that Edge Business School tuition fees do not include UNISA fees. You must ensure that you pay your UNISA fees directly to UNISA before UNISA registration closes.**

There is no registration fee. **Part time lectures commence from Saturday 8 February 2020.** Students may attend the first scheduled session free of charge. Refer to the part time timetable for details of scheduled dates and times for lectures.

- Fees may be settled in full or on terms.
- Payment on terms carries a 5% or 10% administration fee calculated on the sum of the tuition fees.
- The 5% administration fee is applicable where payment is made in 4 instalments, first instalment on registration and remainder commencing 31 January 2020 and ending 30 April 2020.
- A 10% administration fee may only be selected as an alternative where a student has registered for the year (not a semester) and the instalment period is 31 January 2020 to 30 September 2020.
- There will be no extension of payment instalments, students registering after instalment dates have commenced will have recalculated fees over remaining terms / months allocated to specific payment plans.
- There will be a penalty fee of R200 levied on declined/bounced/dishonoured debit orders for which the student will be liable and must be settled along with amount in arrears before access is granted again.
- The administration fee of 5% or 10% will be waived if the account is settled in full by 28 February 2020

PASS PROMISE

- Should a student not pass a module, the student may repeat the module online at no cost provided that:
- The student does all online homework, and obtains at an average of 50% or more for the electronic homework questions and attends 90% lectures.

DISCOUNTS

A student who achieved the following number of distinctions in their UNISA degree in the 2019 calendar year, qualifies for an academic discount on their 2020 fees. Students must register with Edge at the beginning of the year for at least six part time modules for the year to qualify for the academic discount.
