**\*Please note that EBSdotCOZA tuition fees do not include UNISA fees. You must ensure that you pay your UNISA fees directly to UNISA before UNISA registration closes.**

EBSdotCOZA uses the Google classroom to present study material to online students. Through this interface, online help is provided for over 50 UNISA modules.

These courses are either recorded classes of past full or part time lectures for the current and past semesters or may be courses that have been recorded within our in-house studio. Students will require data to access the online offering.

**Note:**

- The full course is offered online and there are no DVD's.
- Printed notes are not supplied. Soft copies are accessible via Google classroom. Candidates are liable for their own data usage costs to access the online course.
- Fees may be settled in full or on terms.
- Payment on terms carries a 5% or 10% administration fee calculated on the sum of the tuition fees.
- The 5% administration fee is applicable where payment is made in 4 instalments, the first instalment on registration and remainder payable from May to July 2021.
- A 10% administration fee may only be selected as an alternative where a student has registered for the year (not a semester) and the instalment period is April to September 2021, the first instalment on registration and remainder payable from May to September 2021.
- There will be no extension of payment instalments, students registering after instalment dates have commenced will have recalculated fees over remaining terms / months allocated to specific payment plans.
- There will be an administration of R300 fee levied on declined/bounced Payfast collections for which the student will be liable and must be settled along with the amount in arrears before access is granted again.
- The administration fee of 5% or 10% will be waived if the account is settled in full by 28 February 2021
