Terms and Conditions:

Payments:

1. A registration must be accompanied by a fully completed application via the Edge registration portal (www.portal.ebs.co.za) / Official Edge Registration form, signed T&Cs (this page) and proof of payment for the course. Once the application form and proof of payment has been received by Edge, it is understood that the student has read and agreed to the Terms and Conditions.

Fees:

1. The fee to settle at registration is R5 500.00 (including 15% VAT).
